TALLANDINE

BRACEBRIDGE, a small scattered village, formerly in the Liberty of Lincoln, but now in Boothby-Graffoe Wapentake, is pleasantly situated on the east side of the river Witham, 2 miles S. of Lincoln, and has in its parish 340 souls, and about 1482 acres of land, belonging to the Fairfax, Frankish, Wilson, and some other families. Lincolnshire County Pauper Lunatic Asylum is in this parish, as already noticed at page 96. Bracebridge Church (All. Saints) is a small ancient structure, consisting of a nave, chancel, south aisle, and tower, covered with flat tiles. The vicarage, valued in K.B. at £3.9s.8d., and now at £203, is in the incumbency of the Rev. Wm. Bromehead, B.A., and in the patronage of Mrs. Brome-The tithes were commuted in 1841 for £226 per annum.

CARLTON-LE-MOORLANDS, a well-built village on one of the tributary streams of the Brant, 8 miles E.N.E. of Newark-upon-Trent, and 11 miles S.S.W. of Lincoln, has in its parish 409 souls, and 2600 acres of land, of which 2004 acres are rateable, and the rest roads, woods, and waste. It has generally a fertile hazle loam, and extends eastward to the Brant, and westward to Scotwater Bridge, on the Witham. Lord Middleton is lord of the manor, and owner of a great part of the soil, and the rest belongs to various freeholders and copyholders. Mr. Joseph and Mr. Wm. Brooklebank have estates and neat houses here. The copyholds are subject to small: certain fines. Lord Middleton is also impropriator of the rectory, and patron of the vicarage, which is valued in K.B. at £7. 0s. 8d., and now at £90, in the incumbency of the Rev. P. G. Willoughby, B.A., who has 29A. 3R. 6P. of glebe, and a yearly rent charge of £36 in lieu of tithes. He has a good residence, and is also vicar of Stapleford, the two benefices being consolidated. The Church (St. Mary) was appropriated to Thornham Priory, and is a neat structure, with a fine tower and a good clock. It was repaired a few years ago, when the old school was added to it. The present school was built in 1854, by subscription. Here is a large Baptist Chapel, with a burial ground. The sum of £30, left for the school and the Poor by John Jessop, in 1707, was laid out with £30, left for the poor by the Rev. - Smith and Wm. Eastland, in the purchase of 1A. 3R. 22P. of land, called East Meadow Close, and now let for up-Wards of £4 per annum. The poor parishioners have also 2A. 3R. 15p. allotted at the enclosure in 1701, and now let for £5. 18s. per annum. Mrs. Brocklebank, in 1820, left the interest of £100 for the support of a Sunday School. Mr. Joseph Brocklebank, in 1846, left the interest of £100 for the school and poor. The schoolmaster has also a yearly gratuity of £10 from Lord Middleton, and the weekly pence paid by the scholars.
